## **FVWDB Finance & Personnel Committee**

**Call to Order:** Chair Walker called the meeting to order at 2:00 PM.

<u>Approval of Agenda</u> (Action Item): A motion was made by Mr. Martinez to approve the agenda and seconded by Mr. Beregszazi. The motion passed.

<u>Approval of Minutes from 11/7/19 Finance and Personnel Committee Meeting (Action Item):</u> A motion was made by Mr. Grant to approve the 11/7/19 meeting minutes and seconded by Mr. Beregszazi. The motion passed.

**Notification: Grant Writer:** Mr. Snyder notified the committee that the Board has terminated its contract with Seliger + Associates.

<u>Employee Health Plan for 2020</u> (Action Item): A motion was made by Mr. Grant to secure health care coverage for employees with Anthem via R&R Insurance, seconded by Ms. Hall. The motion passed.

<u>Worker Compensation Insurance 2019-2020:</u> Mr. Snyder notified the committee the Board received a refund from Employers Preferred Insurance Company in the amount of \$2,054 for this past year's Worker Compensation Insurance. Employers has made a decision to drop our coverage based on the roles held by the Title V participants. Our broker, Greg Goetz from Spectrum Insurance will find us a new provider before 1/6/2020, when current coverage ends.

<u>Dental, Long Term Disability and Term Life/Accidental Death & Dismemberment for 2020:</u> Mr. Snyder reviewed quotes from several providers and recommended the Board engage with Corey Grimes of Van De Hey Financial Services for employee coverage for 2020. A motion was made by Mr. Grant to secure this coverage for employees via Van De Hey Financial Services, seconded by Ms. Hall. The motion passed.

Notification: State of Wisconsin Department of Financial Institutions Annual Report: Mr. Snyder shared the official filing of our nonstock corporation annual report.

<u>Associated Bank Presentation:</u> Associated Bank, the Board's current provider for checking services, welcomed Phil Gatien, Mike Hochholzer, and Tyler Krzewina, who presented on a variety of services. The gentlemen departed. No action was taken.
